Interesting and historical course-related facts

Pinehurst No. 2, the centerpiece of Pinehurst Resort, remains one of the world's most celebrated golf courses. It has served as the site of more single golf championships than any course in America and will make history, becoming the first to serve as host to the U.S. Open and U.S. Women's Open Championships in consecutive weeks.

Opened in 1907, No. 2 was designed by Donald Ross, who called it "the fairest test of championship golf I have ever designed." Ross was associated with the course for nearly a half-century, improving the course continually until his death in 1948. No. 2 is best known for its crowned, undulating greens, which are some of the most complex and widely hailed in the world. Ross believed in providing golfers with strategic choices, and Pinehurst No. 2 was intended to epitomize that philosophy.

In March 2011, No. 2 reopened following a yearlong, \$2.5 million restoration by the design firm Coore & Crenshaw, who restored the course's natural and historic character. The project included the removal of about 35 acres of turf and the reintroduction of hardpan, natural bunker edges and native wire grasses.

Other restoration improvements included widening fairways by about 50 percent; eliminating all rough; stripping about 35 acres of irrigated turf and restoring it to natural areas featuring sand, wire grass, pine straw and native grasses; reducing irrigation heads, down to 450 from 1,125, and restoring the old irrigation lines; eliminating, reshaping or restoring several bunkers, based on aerial images from the 1940s; adding eight new tees to the championship course; and minor modifications to the greens on No. 15 and No. 17.
