Additional Notes

- Wildlife on course: coyotes, javelina, road runners, rabbits, bobcats, bald eagle, hawks, rattle snakes, quail.
- Suffered a monsoon flood in October with 5" of rain in 24 hours which closed the stadium for three days.
- Both the facility and the tournament are Golf Environment Organization (GEO) Certified.
- Expanded desert and cart path re-route at #12.
- Water management and controls include nonoverseeded spectator mounds, individual sprinkler head control via central computer, aeration and wetting agents.
