#### **Notable**

- Markow has been a Certified Golf Course Superintendent (CGCS) for 31 years.
- As of August 14<sup>th</sup> the latest measurable rain was April 26<sup>th</sup> so team has worked hard to manage irrigation, soil moisture and playability.
- The Cypress trees on the course are in one of only two natural ranges of Monterey Cypress in the United States.
- Environmental practices are extremely diligent, especially on holes along the water. Team also routinely removes golf balls from the shallow areas around holes No. 15 and 16.
- Cypress Point hosted the 1981 Walker Cup and was part of the AT&T Pebble Beach Pro-Am rotation from 1947-90.

• The course is consistently ranked in the top three in the United States by various publications.
